Pharmacy Quality Scheme (PQS) 2022-23

1. Mandatory community pharmacy workforce survey - deadline 30 November 2022 [Action]



- Thank you to all those pharmacies who have already completed the current Health Education England (HEE) Community Pharmacy Workforce Survey (CPWS) 2022.
- Completing of the survey is a Terms of Service requirement for contractors.

What do I need to do?

- Individual pharmacies are being contacted by NHS Business Services Authority (NHSBSA) to complete an online survey.
- If your pharmacy is yet to complete the survey, please use the link sent to you by NHSBSA and complete your submission by no later than the deadline of **Wednesday 30 November 2022.**
- Those that do not receive an invitation can expect their head office to submit data on their behalf. If in doubt, check with your head office.
- If you are an NPA Member please do make use of their support and guidance.

Autumn COVID-19 booster and flu vaccine programme

1. A reminder that frontline health and social care staff should get their winter vaccines [Action]



- A reminder that frontline health and social care staff can get their winter vaccines.
- We need to lead the way and demonstrate professional commitment to getting protected on the frontline.
- The COVID-19 booster can be booked either via their employer, or by the staff member booking through the <u>National Booking Service</u>, by calling 119, or using the <u>online vaccination walk-in</u> finder.
- The flu vaccine should be offered through their employer if the staff member is not eligible for the free NHS vaccine due to their age or clinical risk group.
- 2. QIVe flu vaccine not suitable for 65s and over [Action]



- A reminder that you must ensure that the correct flu vaccines are being used for each patient cohort, and that this is being recorded accurately in the patient's clinical record for the NHS Flu Vaccination Service.
- A poster that summarises which flu vaccines should be used for which cohorts can be found on the **GOV.UK website**. Please print this and display it in your consultation room to help to ensure the correct vaccines are administered.

1. <u>Do not request 7-day prescriptions for blister packs unless there is an identified and agreed</u> [Action]

funding of the NHS Pharmaceutical Services has included an element in professional fees received by contractors to recognise the additional cost of complying with disability legislation.

- Recently, a number of pharmacies in Somerset have made requests to GP surgeries for 7-day scripts for patients on blister packs without an identified clinical reason.
- A reminder that Somerset Integrated Care Board (ICB) does not support 7-day prescribing.

- 1. Community Pharmacy Assurance Framework (CPAF) full survey [Information]
- Some community pharmacy contractors will shortly be asked to complete the full version of the Community Pharmacy Assurance Framework (CPAF) questionnaire.
- Pharmacies may be selected for the full CPAF questionnaire if, for example, they did not complete
 the screening questions earlier this year, or if there are concerns about the pharmacy relating to
 patient safety. Some pharmacies may also be selected to validate their answers to the screening
 questions.
- Contractors will have received an email on 7th November by the NHS Business Services Authority if their pharmacy has been selected to complete the full survey. The survey will remain open until midnight on 2 December 2022.

Professional development and wellbeing

- 1. HEE Newly Qualified Pharmacist Pathway [Information]
- The Newly Qualified Pharmacist pathway aims to support a smooth transition from foundation training into to being an independent registered professional. There are four core elements of the pathway:
 - Curriculum: The <u>RPS Post-registration Foundation Pharmacist Curriculum</u> is designed to support pharmacists grow from meeting the initial standards of education and training through to being confident practitioners who can provide increasingly complex care and prepare for a prescribing course.
 - Access to an RPS e-Portfolio: Developed to support learners assess their learning needs, develop an action plan, and reflect upon their experiences.
 - <u>Learning resources library</u>: Curated resources have been mapped against the new curriculum domains.
 - Access to supervision: We will support access to supervision for all pharmacists on this pathway.

- 2. Nicotine vaping in England: 2022 evidence update [Information]
- The recently published Nicotine vaping in England: 2022 evidence update concluded that:
 - in the short and medium term, vaping poses a small fraction of the risks of smoking
 - vaping is not risk-free, particularly for people who have never smoked
 - evidence is mostly limited to short and medium term effects and studies assessing longer term vaping (for more than 12 months) are necessary

- more standardised and consistent methodologies in future studies would improve interpretation of the evidence.
- To increase your knowledge about vaping the National Centre for Smoking Cessation and Training (NCSCT) has a <u>Vaping: a guide for health professionals</u>.
