## Winter vaccinations get underway in the South West

2023-2024 Flu season is now underway with a number of our pharmacies now offering both Covid and Flu Vaccinations on the same visit. Last year pharmacies across the South West delivered 478,377 flu vaccinations, which was another amazing year, with more 65> patients vaccinated than in previous years.

#### **Over 65 Vaccinations**

As a reminder can you please note the requirements for Adjuvanted Quadrivalent Influenza vaccination – last year a larger number of patients were vaccinated with the wrong vaccine which caused a lot of work with contractors to revaccinate patients.

 Adjuvanted Quadrivalent influenza vaccine acronym is AQIV and not ATIV. AQIV is the preferred vaccine for over 65s, and QIVr and QIVc are suitable/recommended alternatives.

Similar to last year, we will contact you to verify any vaccinations given to under 65's and the same process will be followed.

# NHS booking opens for life-saving Covid vaccinations

Millions of eligible people in England can book their life-saving autumn Covid vaccine online as the NHS steps up its winter vaccination programmes early in response to the risk of the new Covid variant.

Anyone eligible can book their Covid vaccinations via the <u>NHS website</u>, by downloading the NHS App, or by calling 119 for free if they can't get online.

Hundreds of thousands of adults who are eligible for winter vaccines – including all aged 65 and over, pregnant women and those with an underlying health condition – will also begin receiving invitations from the NHS to encourage them to get their Covid and flu jabs from this week.

GP practices and other local NHS services will also be contacting people to offer both flu and Covid vaccines, and people can book the flu vaccine by searching online for a local pharmacy.

Over 30 million people are eligible to receive a flu vaccine and over 20 million are able to get a Covid jab.

COVID vaccination for those aged under 18 years will begin later in the year – the NHS will let eligible families know when this offer opens.

This year's adult Covid and flu vaccination programme has been brought forward on the advice of scientists following the emergence of a new covid-19 variant (BA.2.86), which has a high number of mutations.

Health chiefs have ensured there is enough capacity to offer the flu and covid vaccines to all those eligible by the end of October, reflecting the risk of the new variant.

Alongside this, NHS staff have worked hard to prepare for the earlier start of the programme, with almost 5,000 sites – more sites than ever before – taking part in the campaign this year to make it as easy and convenient as possible for people to get protection.

## Visits to NHS website's head lice advice page jump by a third in back-toschool spike

The number of people seeking advice on head lice and nits from the NHS website has increased by more than a third since the beginning of September.

The increase coincides with children returning to school after the holidays. Head lice and nits are common in young children and families, and are passed on through head-to-head contact, not dirty hair.

The <u>NHS head lice and nits advice page</u> helps people identify the small 3mm insects by showing clear images of lice, as well as photos of the empty shells of hatched eggs, known as nits.

It recommends wet combing as the most effective way of treating and preventing head lice by:

- Washing hair with ordinary shampoo
- Smothering hair in any type of conditioner
- Combing the whole head from root to tip with a special fine-toothed detection comb available from pharmacists or online.
- Repeating this process on days 1, 5, 9 and 13 to catch any newly hatched head lice.
- Checking again that everyone is lice-free on day 17.

# Important Reminder: Changes of Director and/or Superintendent Pharmacist

Please don't forget when a body corporate appoints a new director and / or a new superintendent it MUST inform the commissioner within 30 days of the person taking up that new position. Recent experience suggests that contractors sometimes overlook making these declarations.

To make such a declaration you should go to the Primary Care Support England (PCSE) website at <a href="https://pcse.england.nhs.uk/services/pharmacy-market-administration-services/market-entry/">https://pcse.england.nhs.uk/services/pharmacy-market-administration-services/market-entry/</a> where you will be able to complete the necessary declarations.

Failure to notify any changes to directors and / or superintendent pharmacist may be a breach of your terms of service.

# Professional Standards Authority publishes General Pharmaceutical Council (GPHc) performance review for 2022/23

The Professional Standards Authority for Health and Social Care (PSA) has found that the GPhC met 17 out of 18 of its Standards of Good Regulation during 2022/23.

The GPhC's performance and that of other regulators is reviewed regularly by the PSA, with the results reported to Parliament. The aim is to check how well regulators have been protecting the public and promoting confidence in health and care professionals and themselves.

## Maximising uptake of antenatal vaccinations during the Autumn flu and COVID-19 vaccine programmes.

Following the announcement by the Department of Health and Social Care (DHSC) and the UK Health Security Agency (UKHSA) (30 August) in relation to the risks presented by the new BA.2.86 variant of COVID-19, the NHS has been asked to take pre-emptive steps to bring forward the adult COVID-19 and flu vaccination programmes.

While it is difficult to predict the combined effect of the large number of mutations on severity, vaccine escape and transmissibility, expert advice is clear that this represents the most concerning new variant since Omicron first emerged. UKHSA has determined the most appropriate intervention with the greatest potential public health impact is to vaccinate all those eligible, quickly.

## **Reminder: Claiming the Foundation Trainee Pharmacist Grant**

As part of NHS England and the NHS Business Services Authority (NHSBSA)'s new electronic system for Foundation trainee grant registration, **from September 14**, pharmacy owners can register trainee pharmacists through the NHSBSA's Manage Your Service (MYS) portal.

Payments will be made monthly, covering the period between the grant application and the start of training. # Return of Serious Untoward Incidents for Q2 (July 2023 – September 2023)

Practices participating in DSQS are required to report all serious untoward incidents relating to dispensing to the South West Collaborative Commissioning Hub for the purpose of reviewing and learning from incidents.

As in previous years we are continuing to ask for returns to be submitted on a quarterly basis to reduce the amount of information you are required to collate later in the year. We are currently asking returns for Quarter 2 (01 July to 30 September.

Whilst we would ideally prefer you to return quarterly this is only voluntary and you do still have up until the end of the year to submit all your information.

If you have not already done so, can you please complete the return for Quarter 2 (1 July – 30 September 2023) and forward to <a href="mailto:england.pharmacysouthwest@nhs.net">england.pharmacysouthwest@nhs.net</a> by 31 October 2023. Please ensure that all the practice details on the return form are completed before sending back.

## **Shortages**

## **Central Alerting System (CAS)**

Shortage of Methylphenidate Prolonged-Release Capsules and Tablets, Lisdexamfetamine Capsules, and Guanfacine Prolonged-Release Tablets

There are supply disruptions affecting various strengths of the following medications which are licensed for the treatment of attention deficit hyperactivity disorder (ADHD):

- Methylphenidate:\* Equasym XL® 10, 20 and 30 mg capsules
- Xaggitin XL® 18 and 36 mg prolonged-release tablets
- Concerta XL® 54 mg prolonged-release tablets
- Xenidate XL® 27 mg prolonged-release tablets
- Lisdexamfetamine: Elvanse® 20, 30, 40, 50, 60 and 70 mg capsules
- Elvanse® Adult 30, 50, and 70 mg capsules
- Guanfacine: Intuniv® 1, 2, 3 and 4 mg prolonged-release tablets T

The supply disruption of these products is caused by a combination of manufacturing issues and an increased global demand. Other ADHD products remain available but cannot meet excessive increases in demand.

At present, the supply disruptions are expected to resolve at various dates between October and December 2023.

# **Serious Shortage Protocols (SSPs)**

Because of ongoing supply issues, we are extending the Serious Shortage Protocols (SSPs) currently in place for Clarithromycin 125mg/5ml oral suspension and Clarithromycin 250mg/5ml oral suspension (SSPs 053 and 054) which are due to end on Friday 29 September.

The new end date for SSPs 053 and 054 is Friday 17 November.

SSP056 (Utrogestan® 100mg capsules) is not being extended and ends on Friday 29 September.

## **DHSC Medicine Supply Notifications**

Hyoscine hydrobromide (Scopoderm®) 1.5mg patches

Tier 2 – medium impact Date of issue: 21/09/2023 Link: Medicines Supply Tool

#### **Summary**

- Hyoscine hydrobromide (Scopoderm®) 1.5mg patches are in limited supply until w/c 1 st January 2024
- Alternative formulations of hyoscine hydrobromide remain available and will be able to the support an increase in demand.
- Glycopyrronium tablets and liquid remain available and will be able to the support an increase in demand.
- Where these are not suitable, unlicensed supplies of hyoscine hydrobromide patches may be sourced, lead times vary (see Supporting information).

Discontinuation of lixisenatide (Lyxumia®) 20micrograms/0.2ml solution for injection 3ml pre-filled disposable devices

#### Summarv

- Lixisenatide (Lyxumia®) 20micrograms/0.2ml solution for injection 3ml pre-filled disposable devices are being discontinued and stock will be exhausted by w/c 18th December 2023.
- Please refer to the Medicines Supply Tool on the Specialist Pharmacy Service (SPS) website for a supply update of other glucagon-like peptide receptor agonists (GLP-1 RA) and clinical guidance on alternative treatment options.
- Information in the National Patient Safety Alert (NatPSA) on the shortage of GLP-1 receptor agonists issued on the 18thJuly 2023 can be used to guide management of patients switching from lixisenatid

Somatropin (Genotropin® MiniQuick) 1.4mg powder and solvent for solution for injection pre-filled disposable devices

Somatropin (Genotropin® MiniQuick) 1.6mg powder and solvent for solution for injection pre-filled disposable devices

Somatropin (Genotropin® MiniQuick) 1.8mg powder and solvent for solution for injection pre-filled disposable devices

#### **Summary**

- Somatropin (Genotropin® MiniQuick) 1.4mg, 1.6mg and 1.8mg powder and solvent for solution for injection pre-filled disposable (single dose) devices will be in limited supply until w/c 1st January 2024.
- The following somatropin preparations remain available and will be able to support increased demand:

- Somatropin (Genotropin® GoQuick) 12mg powder and solvent for solution for injection prefilled, multidose pens
- Somatropin (Genotropin®) 12mg powder and solvent for solution for injection multi-dose cartridges
- Somatropin (Genotropin® MiniQuick) 1.2mg and 2mg powder and solvent for solution for injection prefilled disposable (single dose) devices

Disopyramide (Rythmodan® )100mg capsules

Tier 2 – medium impact
Date of issue: 27/09/2023

#### **Summary**

- Disopyramide (Rythmodan®) 100mg capsules are out of stock until late October 2023.
- Disopyramide (Rythmodan®) 250mg prolonged release tablets are out of stock until mid-December 2023 but parallel imports remain available and can fully cover demand.
- Limited stock of parallel imports of disopyramide 100mg are available and can partially cover demand for 100mg capsules.
- Unlicensed imports of disopyramide 100mg capsules and disopyramide 250mg prolonged release tablets have been sourced, lead times vary.

Azelaic acid (Skinoren®) 20% cream

Tier 2 – medium impact Date of issue: 27/09/2023 Link: Medicines Supply Tool

#### **Summary**

- Azelaic acid (Skinoren®) 20% cream is out of stock until early November 2023.
- Azelaic acid (Finacea®) 15% gel remains available but cannot support an uplift in demand.
- Alternative topical treatments remain available and can support an uplift in demand.

DHSC and NHSE/I have now launched an online <u>Medicines Supply Tool</u>, which provides up to date information about medicine supply issues. The contents of these MSNs can now be viewed on the Tool. #### **NHS Smart Card**

Could all contractors please ensure all pharmacists, especially locums, are reminded to ensure they have their smartcard with them for all shifts. This is especially critical at weekends and on bank holidays as there is likely to be more limited access to pharmaceutical services on these days.

If you have received automated messages about NHS smartcard renewal, please renew them as soon as possible.

If NHS Digital do not manage to increase the rate of renewal now, it will inevitably result in a rush of users requiring smartcard renewals through the Care Identity Service with increasing urgency.

This could lead to delays in access to systems and services, due to backlogs of renewals being requested for processing by Registration Authorities. Any impact on the Care Identity Service will not affect authentication and access to clinical systems for users with a valid smartcard. # **Community Pharmacy Complaints**

The current primary care complaint's function transferred from NHS England to ICBs in July 2023. Primary care services include GPs, dentists, opticians, and pharmacy services.

From 1 July 2023 the way members of the public make a complaint about primary care services to the commissioner has changed. Rather than contacting NHS England or their contact centre they must now contact the ICB where the patient is located.

Therefore, all Pharmacies should now update their information for patient complaints, displaying the correct contact details for their area. Below are the links to the relevant ICB websites showing the details you will need to update your SOP and patient poster.
