Mandatory 2023 Community Pharmacy workforce survey – complete by 17th December 2023



Find out more about the 2023 Community Pharmacy workforce survey and how to access it

The 2023 Community Pharmacy Workforce Survey (CPWS23) is open until Sunday 17th December 2023. This annual survey has been part of the community pharmacy regulations since 2022, recognising the priority the NHS places on the community pharmacy workforce, and the importance of collecting consistent, accurate data to support effective workforce planning.

It is vital that we build an accurate picture of current workforce reality in our county.

All pharmacy owners are required to complete the survey. The NHS Business Service Authority (NHSBSA) has sent an email to pharmacy owners with a link to the survey. In some cases, head offices will complete the survey for multiple pharmacy groups.

About the CPWS23:

- As per previous surveys, CPWS23 focuses on the number of staff, the number of full-time equivalents (FTE) and any vacancies in each of ten staff categories employed in community pharmacy. The survey also asks about any trainees in the pharmacy.
- Data collection methods and survey format are "familiar and similar" to 2022 with an online survey and Excel template for Head Office completion.
- The NHSBSA sent an email to pharmacy owners containing a link to the survey on 23rd October 2023.
- An Excel template and crib sheet have been shared with key stakeholders to cascade to their members.
- The survey is conducted by North of England Commissioning Support Unit (NECS) on behalf of NHS England.
- More information is available in Frequently Asked Questions on the <u>Health Education</u> <u>England website</u> and on the <u>Community Pharmacy England website</u>.
- The survey data and key findings will be available in 2024 to contribute to developing information on workforce and build a picture of the community pharmacy workforce.

The full CPAF survey monitoring pharmacy contractors' compliance in 2022/23 is available until midnight on 3 December 2023. Contractors will be contacted directly by the NHS Business Services Authority if their pharmacy has been selected. Completion is a mandatory requirement



for all selected contractors and the results will form the basis for which pharmacies will be considered for a visit. Users of the <u>NHSBSA's Manage Your Service (MYS) portal</u> will be able to complete the survey via their MYS login.

Community Pharmacy Somerset Independent Prescribing Survey [please complete or update]



Whether you are already an independent prescriber (IP), training now, about to start training, would like to train, are unsure or have no intention to train, please would you complete the Community Pharmacy Somerset independent prescribing survey as soon as possible. If you have already completed the survey, please resubmit if

anything has changed since you first filled it in. This will enable us to keep you updated with any developments to facilitate as many community pharmacists to train as IPs, such as the <u>NHSE</u> <u>Teach and Treat pilot</u> and the <u>NHSE Community pharmacy independent prescribing</u> <u>pathfinder project</u> within Somerset integrated care system (ICS).

You may also consider completing the <u>CPPE Preparing to train</u> <u>as an independent prescriber programme</u> which aims to build the confidence and competence of pharmacists who are planning to apply and train as independent prescribers.

Your LPC is working with the Somerset Council Public Health team on a plan to replace the Somerset safeguarding and child exploitation online workshop with a video/e-learning to remove the need to attend a session at a fixed date and time. We will let you know when this is available.

In the meantime important action for pharmacists: If your review and update of your <u>Declaration of Competence for Emergency contraception</u> is due (every two years), and you wish to continue to provide the service, please do this now at the CPPE website.

Please check that you have agreed for your data to be shared with PharmOutcomes in <u>MyCPPE</u>. Login, scroll down to PharmOutcomes and ensure the box to allow your data to be shared with PharmOutcomes, is ticked.

Please also read, review and sign the current <u>Somerset Levonorgestrel and Ulipristal PGDs</u> and retain copies of the signed PGDs in all the pharmacies that you work in.

Naloxone quick intervention service – whole pharmacy team to complete updated training



Thank you again for joining this life saving scheme

which aims to prevent drug related deaths in Somerset. We are very pleased to report that since launch in September **28 kits have been supplied through pharmacies.** This is great but we know more can be supplied.

The Somerset pharmacy quick intervention naloxone supply scheme and training have been updated as part of a wider project to encourage people at risk of witnessing or experiencing an opioid overdose to carry naloxone. The model of supply is based on research funded by Pharmacy Research UK. The updated training should be completed by every member of your community pharmacy team, whether or not they have completed the previous training and is as follows:

- Watch a recording of the training webinar (one hour)
- Access the essential links in red embedded in the <u>slide presentation</u>. NB, you need to watch the video as well as reading the slides and accessing the essential links.
- The links in blue within the presentation are optional if you would like to extend your learning.

Running the service:

If you have not done so already, please remember to do the following:

• Make sure you can access your Exchange Supplies account to order naloxone, any problems contact Louise Evans louise@exchangesupplies.org

• Make sure you have at least one injectable (Prenoxad®) and one nasal naloxone (Nyxoid®) in stock at all times.

• You and your whole team should offer naloxone to all your opioid substitution therapy (methadone or buprenorphine) clients and if you provide needle exchange, offer naloxone to everyone who uses this service.

• Keep offering periodically as you feel appropriate. Please also make supplies if people ask for it.

• We will let you know how to access carry cases and paper maps of all outlets in Somerset when they are available.

Lateral flow device tests supply advanced service

The lateral flow device (LFD) tests supply service for patients potentially eligible for COVID-19 treatments launched on 6 November 2023. Eligible patients can obtain a free box of five LFD tests from community pharmacy.



NHS LFD Tests Supply Service: Advanced Service A positive LFD result will be used by the prescriber to inform clinical assessment to determine whether the patient will benefit from COVID-19 treatments. The full list of eligibility criteria can be found in the NICE recommendations for COVID-19 community treatments.

Who can get free <u>NHS</u> prescriptions?



Free NHS prescriptions eligibility checking tool for patients

NHSBSA Prescription Prepayment Certificates A new NHS England campaign aims to raise awareness of prescription saving schemes. A Prescription Prepayment Certificate will save people money if they pay for more than three items in three months, or 11 items in 12 months. People on a low income could be entitled to help with costs or free prescriptions through the low-income scheme, depending on their circumstances. Healthcare staff are urged to remind their patients about these schemes – particularly those living with long-term conditions and

people living in deprived areas where evidence shows that people receive significantly more prescription items than those living in less deprived areas.

Pharmacy blood pressure service check finder tool

Blood pressure pharmacy service check finder tool



A new service finder on NHS.uk allows healthcare professionals and patients to search for and find a pharmacy that offers free blood pressure checks.

The tool explains who is eligible to go to a pharmacy to get their blood pressure checked and can be searched using a postcode, with the nearest pharmacy listed first.

All pharmacy contractors offering the service should ensure their **pharmacy profile on profile manager** is up to date and indicates that they provide the service.

Isotretinoin (Roaccutane ▼): introduction of new safety measures

Medicines & Healthcare products Regulatory Agency

The <u>MHRA has strengthened the safe use of isotretinoin</u> through the introduction of additional oversight of the initiation of



isotretinoin in patients under 18 years and through improved assessment and monitoring of mental health and sexual function issues. Healthcare professionals are asked to review these new measures and supporting materials and integrate them into their clinical practice when referring patients and when prescribing or dispensing isotretinoin.

National patient safety alert and guidance on GLP-1 prescribing







There are ongoing supply issues with GLP-1 receptor agonists used to treat diabetes and for off-label weight loss. A

National Patient Safety Alert, issued on 18 July, outlines actions for prescribers.
