New Service Launch: Lateral Flow Device Tests Supply Advanced Service

On Monday 6 November 2023 the 'Lateral Flow Device Tests Supply Service' will be launched, enabling the supply of Covid-19 Lateral Flow Devices from the pharmacy to patients that form part of the eligible cohort. The full list of eligibility criteria is determined by the National Institute for Health and Clinical Excellence (NICE) and can be found in the NICE guidelines <u>'Supporting information on risk factors for progression to severe COVID-19'</u>.

A fee of £4.00 (plus VAT) will be paid for each completed transaction of the supply of one box of five Covid-19 Lateral Flow Devices and the cost of tests supplied will be paid according to arrangements set out in the November 2023 Drug Tariff.

NHS delivering fastest ever Flu Vaccine rollout ahead of winter

The lifesaving <u>NHS winter vaccination programme has delivered more than ten million flu jabs</u> (10,527,579) and over seven million Covid vaccines (7,525,637) to people most at risk across England in just over five weeks, making this the fastest NHS flu vaccine roll out on record.

A record three million people have received their flu and Covid vaccines in the same appointment, as vaccine providers make it as convenient as possible for people to get protected ahead of winter.

Reminding patients about prescription saving schemes

A new NHS England campaign aims to raise awareness of prescription saving schemes. A Prescription Prepayment Certificate will save people money if they pay for more than three items in three months, or 11 items in 12 months.

People on a low income could be entitled to help with costs or free prescriptions through the low-income scheme, depending on their circumstances. Healthcare staff are urged to remind their patients about these schemes – particularly those living with long-term conditions and people living in deprived areas where data shows people receive significantly more prescription items than those living in less deprived areas.

Community Pharmacy Assurance Framework (CPAF)

The full CPAF survey monitoring pharmacy contractors' compliance in 2022/23 will be available to complete from 6 November until midnight on 3 December 2023.

Contractors will be contacted directly by the NHS Business Services Authority if their pharmacy has been selected.

Completion is a mandatory requirement for all selected contractors and the results will form the basis for which pharmacies will be considered for a visit. Users of the NHSBSA's <u>Manage Your Service (MYS) portal</u> will be able to complete the survey via their MYS login.

2023 Mandatory Workforce Survey

The 2023 Community Pharmacy Workforce Survey, conducted by North of England Commissioning Support Unit (NECS) on behalf of NHS England, opened Monday 23 October 2023.

Completion of the survey is a mandatory requirement for all pharmacy owners.

The NHSBSA have now sent an email to pharmacy owners containing a link to the survey.

In some cases, e.g., Company Chemists' Association member companies and other multiple pharmacy groups, head offices will complete the survey centrally. If you are not sure whether the survey will be completed centrally, please ask your head office for guidance.

The survey is open for eight weeks and will close on Sunday 17th December 2023.

Health Promotion

Community Pharmacy Blood Pressure Check Service and Pharmacy Contraceptive Service

A pharmacy blood pressure check service finder tool for the public and patients is now available.

The new service finder on the NHS website (NHS.UK) allows healthcare professionals and patients to search for and <u>find a pharmacy that offers free blood pressure checks.</u>

The tool explains who is eligible to go to a pharmacy to get their blood pressure checked and can be searched using a postcode, with the nearest pharmacy listed first.

Blood pressure conditions pages on the NHS website have also been updated to signpost to the blood pressure pharmacy finder.

All pharmacy contractors offering the service should ensure that their pharmacy profile on <u>NHS Profile Manager</u> is up to date and indicates that they provide the service. This will ensure that all pharmacies which offer the service located nearest the postcode provided will be listed.

NHS Service finder for healthcare professionals

The NHS Service Finder for healthcare professionals (provided by the UEC Directory of Services team) will shortly be expanded to include the ability to search for pharmacies providing NHS Community Pharmacy Blood Pressure Check and NHS Pharmacy Contraception Services.

Ask Your Pharmacist Week 2023

Ask Your Pharmacist Week is an annual awareness-raising campaign organised by the National Pharmacy Association (NPA) and supported by NHS England and runs from 30 October - 6 November.

This year's theme is 'Meet Your Local Pharmacy Team', aiming to raise awareness of the NHS services and skilled staff available in their local pharmacies with the strapline -Convenient, clinical care. Free campaign materials are available on the NPA website.

Dispensing Doctors

Dispensing Services Quality Scheme (DSQS) 2023/24 Completion of Self Declaration Form

All dispensing practices signed up for DSQS 2022/24 will have recently received an email requesting completion of the self-assessment/declaration of compliance form.

As in previous years each dispensing practice is required to complete a self-assessment/declaration of compliance form. Dispensing practices will be required to make declarations as to whether the practice is fully, partially, or not compliant with the requirements of the DSQS specification and guidance. If, for any statement, the practice is partially or not compliant, further information will need to be provided.

Once completed, please email the spreadsheet to <u>england.pharmacysouthwest@nhs.net</u> by no later than **Friday 26 January 2024.** This ensures that there is time for the team to review all submissions and for any queries to be resolved before the deadline of 31 March 2023.

If you have not received a copy of the self-assessment/declaration of compliance form then please contact england.pharmacysouthwest@nhs.net and a member of the team will arrange for a copy to be sent.

DHSC Medicine Supply Notifications

Bisacodyl (Dulcolax®) 5mg suppositories Tier 2 – medium impact Date of issue: 23/10/2023 Link: Medicines Supply Tool

Summary

- Bisacodyl (Dulcolax®) 5mg suppositories are out of stock until w/c 18th December 2023.
- Glycerol 2g (children's size) suppositories remain available but are unable to support any increased demand.
- Relaxit enemas are out of stock without a current resupply date.
- Micralax micro enemas remain available but can only partially support any uplift in demand.
- Unlicensed supplies of bisacodyl 5mg suppositories from special-order manufacturers may be sourced, lead times vary.

Lamotrigine 5mg dispersible tablets Tier 2 – medium impact Date of issue: 24/10/2023 Link: <u>Medicines Supply Tool</u>

Summary

- Generic lamotrigine 5mg dispersible tablets are out of stock until mid-February 2024
- Branded lamotrigine (Lamictal®) 2mg and 5mg dispersible tablets remain available but cannot fully support the gap in the market.
- A few Specials manufacturers are able to produce unlicensed lamotrigine 5mg/5ml and 25mg/5ml oral suspension (including sugar-free formulations).
- Where the above options are not suitable, unlicensed supplies of lamotrigine (Lamictal®) 5mg dispersible tablets may be sourced, lead times vary

DHSC and NHSE/I have now launched an online <u>Medicines Supply Tool</u>, which provides up to date information about medicine supply issues. The contents of these MSNs can now be viewed on the Tool. Updating NHS Website Profile and DoS Profile

Please ensure you update any changes required on your pharmacy's NHS website profile and your DoS profile, i.e., opening times, contact information and services information you provide.

NHS Smart Card

Could all contractors please ensure all pharmacists, especially locums, are reminded to ensure they have their smartcard with them for all shifts. This is especially critical at weekends and on bank holidays as there is likely to be more limited access to pharmaceutical services on these days.

If you have received automated messages about NHS smartcard renewal, please renew them as soon as possible.

If NHS Digital do not manage to increase the rate of renewal now, it will inevitably result in a rush of users requiring smartcard renewals through the Care Identity Service with increasing urgency.

This could lead to delays in access to systems and services, due to backlogs of renewals being requested for processing by Registration Authorities. Any impact on the Care Identity Service will not affect authentication and access to clinical systems for users with a valid smartcard. Community Pharmacy Complaints

The current primary care complaint's function transferred from NHS England to ICBs in July 2023. Primary care services include GPs, dentists, opticians, and pharmacy services.

From 1 July 2023 the way members of the public make a complaint about primary care services to the commissioner has changed. Rather than contacting NHS England or their contact centre they must now contact the ICB where the patient is located.

Therefore, all Pharmacies should now update their information for patient complaints, displaying the correct contact details for their area. Below are the links to the relevant ICB websites showing the details you will need to update your SOP and patient poster.
