Initial Education and Training of Pharmacists (IETP) Reforms and Trainee Pharmacists 2025–26



As part of the reforms to the initial education and training of pharmacists (IETP) most pharmacists joining the GPhC register from summer 2026 will be annotated as independent prescribers (IP) at the point of registration.

The Oriel application process for the 2025–26 foundation training year starts in January 2024. If you would like to find out more, especially if you are planning to employ or provide a placement for a trainee pharmacist in 2025–26, we recommend that you listen to a recording of an NHSE WT&E SW webinar about the reforms held on 8th November 2023.



Delivery Plan for Recovering Access to Primary Care: Pharmacy First Service and Expansion of NHS Pharmacy Contraception and Hypertension Case-Finding Services

NHS England Community Pharmacy England (CPE) has reached an agreement with the Department of Health and Social Care (DHSC) and NHS England (NHSE) on the launch of a National Pharmacy First Service as well as other changes to pharmacy funding and services.

Community pharmacies that have not yet opted in or registered to deliver these services, are encouraged to do so from 1st December 2023, by registering via the 'Manage Your Service' platform.

NHS Pharmacy First Service Specification, Clinical Pathways, draft PGDs and Clinical Protocols published



The service specification, clinical pathways, draft Patient Group Directions (PGDs) and protocol for the new Pharmacy First Service (PFS), which is due to commence at the end of January 2024, have been published. In the consultations with a pharmacist, people with symptoms suggestive of seven conditions will be provided with advice and will be

supplied, where clinically necessary, with a prescription-only treatment under a Patient Group Direction (PGD).

The seven conditions are: sinusitis, sore throat, acute otitis media, infected insect bite, impetigo, shingles and uncomplicated urinary tract infections in women. The new Pharmacy First Service will also include current elements of the Community Pharmacist Consultation Service; minor illness consultations and urgent supply of medicines, for people referred to the pharmacy.

Expansion of NHS Pharmacy Contraception Services



The new service will enable the supply, or repeat supply, of oral contraception for the first time or switch from one type of oral contraception to another.

Training requirements – additional training requirements have now been included to support the initiation of contraception. <u>Find out more at the CPE Pharmacy Contraception Service</u> <u>webpage.</u>

Community pharmacies will now be able to sign up to deliver the expanded NHS Pharmacy Contraception Service, to include the initiation of oral contraception, from 1st December 2023. Contractors who have registered to deliver the current Tier 1 NHS Pharmacy Contraception Service on or before 30th November 2023, must opt-in to the new extended service via the Manage Your Service (MYS) system, by 29th February 2024.

Changes to the NHS Community Pharmacy Hypertension casefinding service



The NHS Community Pharmacy Blood Pressure Check Service which is already being delivered by pharmacists and pharmacy technicians, can now be delivered by trained members of the wider pharmacy team, who will work within their scope of practice alongside pharmacists and pharmacy technicians, from 1st December 2023.

An updated <u>Service Specification</u> has been issued for this service. Please ensure that all team members are aware of this. The main points to note are that the service can now be provided by suitable trained and competent pharmacy staff ie, pharmacists, pharmacy technicians and other non-registered members of the pharmacy team.

Please also note that your pharmacy MUST ensure they have both a blood pressure monitor and an ABPM device that meets the requirements stated in the service specification.

NHS Profile Manager Updates for Community Pharmacy services



NHS Profile Manager is the tool that pharmacies use to update their profiles for the NHS website and urgent care services.

The Terms of Service require contractors to update NHS Profile Manager at least once a quarter to ensure the pharmacy's information is kept up to date.

Pharmacy contractors should ensure their service information for services they provide is up to date on their profiles using NHS Profile Manager. Once updated to confirm these services are provided, the pharmacy will be included in search results for the area.





National Patient Safety Alert: Valproate



The Medicines & Healthcare products Regulatory Agency (MHRA) is asking healthcare organisations, including community pharmacies, to put a plan in place to implement new regulatory measures for

sodium valproate, valproic acid and valproate semisodium (valproate). This follows a comprehensive review of safety data, advice from the Commission on Human Medicines and an expert group, and liaison with clinicians and organisations.

Regulations laid out by the <u>Department of Health and Social Care (DHSC)</u> in the Terms of Service for pharmacists require all pharmacy contractors to complete the Community Pharmacy Workforce Survey. A final reminder that the survey closes **at 11:59pm on Sunday 17th December 2023**. This annual survey has been part of the community pharmacy regulations since 2022, recognising the priority the NHS places on the community pharmacy workforce, and the importance of collecting consistent, accurate data to support effective workforce planning.

It is vital that we build an accurate picture of current workforce reality in our county.

The NHS Business Service Authority (NHSBSA) has sent an email to pharmacy owners with a link to the survey. In some cases, head offices will complete the survey for multiple pharmacy groups. Further information is available at the **Community Pharmacy England website**.

In the meantime important action for pharmacists: If your review and update of your <u>Declaration of Competence for Emergency contraception</u> is due (every two years), and you wish to continue to provide the service, please do this now at the CPPE website!

Please check that you have agreed for your data to be shared with PharmOutcomes in MyCPPE. Login, scroll down to PharmOutcomes and ensure the box to allow your data to be shared with PharmOutcomes is ticked.

Please also read, review and sign the current <u>Somerset Levonorgestrel and Ulipristal PGDs</u> and retain copies of the signed PGDs in all the pharmacies that you work in.

Supplying naloxone from community pharmacies:
Somerset scheme (update, 2023)

Thank you again for joining this life saving scheme which aims to prevent drug related deaths in Somerset. We are very pleased to report that since launch in September 28 kits have been supplied through pharmacies. This is great but we know more can be supplied.

The Somerset pharmacy quick intervention naloxone supply scheme and training have been updated as part of a wider project to encourage people at risk of witnessing or experiencing an opioid overdose to carry naloxone. The model of supply is based on research funded by Pharmacy Research UK. The updated training should be completed by every member of your community pharmacy team, whether or not they have completed the previous training and is as follows:

- Watch a recording of the training webinar (one hour)
- Access the essential links in red embedded in the <u>slide presentation</u>. NB, you need to watch the video as well as reading the slides and accessing the essential links.
- The links in blue within the presentation are optional if you would like to extend your learning.

Please promote this training to your whole team including relief, part time and locum staff to ensure this important service is made as accessible as possible.

Running the service:

If you have not done so already, please remember to do the following:

• Make sure you can access your Exchange Supplies account to order naloxone, any problems contact Louise Evans louise@exchangesupplies.org





- Make sure you have at least one injectable (Prenoxad®) and one nasal naloxone (Nyxoid®) in stock at all times.
- You and your whole team should offer naloxone to all your opioid substitution therapy (methadone or buprenorphine) clients and if you provide needle exchange, offer naloxone to everyone who uses this service.
- Keep offering periodically as you feel appropriate. Please also make supplies available if people ask for it.

- We will let you know how to access carry cases and paper maps of all outlets in Somerset when they are available.
