Getting Started: Stage 1

- 1. All pharmacies must register to provide the Pharmacy first service via their MYS portal. To receive a one-off payment of £2000, you MUST register by 11.59pm on 30 January 2024.
- If you register for the service after 11.59pm on 30th January, you can still provide the service but you will NOT qualify for the £2000 one off payment.

Be Prepared and Gain Knowledge: Stage 2

- 1. All pharmacists, including locums must read the service specification.
- 2. All pharmacists, including locums must read all the associated final PGDs for the seven common conditions.
- 3. Get familiar with the service by accessing the resources at the <u>CPE Pharmacy First Service webpage.</u>
- 4. Download the <u>NHS Pharmacy First self-assessment framework</u> and access the recommended learning and resources for the learning and knowledge gaps you have identified via the <u>CPPE NHS Pharmacy First service webpage.</u>

2. Upskill your community pharmacy technicians to fully engage in service delivery and clinical assessment skills to support new services being offered through community pharmacy by





encouraging them to complete the <u>CPPE Community pharmacy technician: advancing</u> <u>your role programme.</u>

- 3. Brief your teams-they may come across patients who are eligible for the service who they can encourage to engage. Emphasise that walk in patients are allowed to access the service as well as referrals.
- 4. Communicate regularly with your team; hold daily huddles to discuss the service, who is eligible and any opportunities missed.
- 5. Brief your surgeries that you are ready to start the service and communicate what can the surgery teams do to assist you.

Claim for the service: Stage 4

- 1. All claims for Pharmacy First service must be submitted via your MYS portal monthly.
- 2. Remember the threshold to maximise the payments your pharmacy can receive by doing the minimum amount of pharmacy first provisions as set out at the <u>CPE Pharmacy First service</u> <u>webpage</u>.
